Cllr D Green informed the members that previous surveys showed that the residents were against this proposal. Cllr R Orsler proposed that the bid for funding is for a dropped kerb to the KGV in Wellington Avenue.

Cllr A Turner reminded the members that the Town Council had agreed to request for a grit bin for the residents of Whiteleaf by applying for funding under the scheme. (Ref minute g 08/2010).

**All present agreed** to apply for funding for work to drop the kerb to the KGV in Wellington Avenue and as many grit bins as the budget would allow.
