The tree in question could not be examined at close quarters but, if the lower body is sound then the arboriculturalist might be able to suggest management by means of pruning. It does appear to be top heavy.

It could not be determined whether the tree was on the boundary line between Rectory Court and Clifford Road, or fully on the garden area of Flat No 9. It does appear to be part of the screening, enjoyed by residents of Clifford Road, from the buildings on the site of the re-development at Merton House.

The tree plan agreed at the time of the development did not recommend felling the tree although, apart from the protected yew trees , many others were, sadly, felled.

Once again we must defer to the expertise and advice of the District Arboriculturalist

(The Arboriculturalist decided, on inspection of the self-seeded, malformed tree, that it was not covered by the existing TPO and could be removed. The application was voided.)

The Town Council cannot support a retrospective application, particularly when the profession of the applicant suggests that he should be fully aware of the requirements of Planning Law in respect of applications to build.

The information gleaned from the limited scope of the plans provided, suggests that this replacement building is more robust and larger than a typical garden shed, having a clay tiled roof and larch cladding, possibly over a 'breeze-block' type structure, on a concrete base.

Were this to have been presented as a new building, the Town Council would probably have objected strongly, suggesting that it represented more of a weatherproof storage area for building materials suited to the applicant's trade, rather than a family amenity in a residential garden, and would therefore be totally inappropriate.
