

### **TOWN REPORT**

The Town Committee, along with its various sub committees and working groups, have been beavering away since my last report in an endeavour to keep the town spic and span, and the parks and recreation grounds in good health and below is just a digest of what has gone on.

### **Britain in Bloom**



As I reported in my last article, we again entered the Britain in Bloom Competition and were very pleased with the results, which were better in all three sections. Yet again we were rewarded with a Silver for the town as a whole and a Silver Gilt for the Stratton Memorial Garden.

However, the Working Group is now aware that the amount of work that needs to be done if we are to progress further is much greater than we alone can effectively manage and as such would appeal to anyone in the community who has an interest in getting us up to Gold Award to contact us, with a view to either serving on the working group or offering to help in the cleanup and enhancement of the town for next year.

The judging takes place in early July but we have to start work on the planning much earlier, so please come forward if you would like to help. We are particularly appealing to those of a younger age so that we can create a continuity in the group.

### **Market House**

If you have been in the town of late you have probably noticed the fencing and latterly the scaffolding that has gone up around the Market House. This is in place because at long last we have started work on the building refurbishment which will take around 12 to 16 weeks in total and should complete early in the New Year.

When it is complete the building will once again be available for use by small committees or groups that need a place to meet. As well as ensuring that the building is made safe we are improving facilities with the installation of a toilet and small refreshment area. The clock is being overhauled and a new staircase is to be added which will bring the building almost back to how it would have been in days gone by.

We apologise for any inconvenience that this work may cause and hope that you will see it as a positive step forward in improving the town centre.

### **Crescent Play Area**



The plans are now in and contractor engaged for the upgrading of the play area in the Crescent Recreation Ground. The plans were drawn up with the help of a focus group of children of the ages that we hope this play area will attract and work should start soon on the installation.

### **PARKS REPORT**

We are pleased that the path across King George Vth recreation ground has been completed and that this will enable the public to cross the field without getting muddy at the Aylesbury Road end. In the St. Dunstan's Recreation Ground it has come to our attention that someone has drawn a goal mouth on the side of the Dovecote and seems to be regularly using the wall for football practice. We would ask whoever has done this to desist from their actions as this is a very fragile building that already requires a great deal of expensive maintenance and it should be noted that it has a Grade II listing. We will put up notices stating that no ball games should take place in the vicinity of this 13th Century building so that no further damage can result.

#### **Weed Spraying Policy**



You may have noticed that along with other towns and villages there are a plethora of weeds left untreated this year. This is due to an EU Directive introduced primarily for the farming

community but is equally applicable to any business/local authority.

The substance found in most weed killers (neonicotinoid) is now a banned substance for use by any commercial organisation. The measure is to protect bees as well as humans from exposure as it has been confirmed that the neonicotinoid substance kills bees as they collect pollen from dandelions etc.

The only weed killer without this banned substance in is Roundup.

However, the key ingredient in Roundup is glyphosate which the World Health Organization's International Agency for Research on Cancer has said that it "probably" has the potential to cause cancer in humans. Glyphosate has been given an 18-month extension until a new ruling on its safety is provided by the European Chemical Agency, by the end of 2017. Research shows that higher levels of respiratory illnesses have been found in towns that regularly use glyphosate.

Other local authorities do not find Roundup is effective on weeds unless used very regularly due to the increased weeds resistance to the substance. This together with the above information has resulted in the Town Council withdrawing from a regular weed spraying programmes.

### **Benches**

Two of the most used benches in the town, those outside the George and Dragon in the High Street and used by those awaiting the bus, will be refurbished soon. This will possibly necessitate the removal of them, one at a time, and so there will be some inconvenience to the travelling public, but we will try to keep that to a minimum.

We are constantly being offered commemorative benches for installation in the town, usually they are asked to be placed in the Stratton Memorial Garden but there is no longer any need for further benches there, so if you know of a place in town where there is the need for a bench then please contact us with your thoughts.

### **Wades Park Master Plan**



Some weeks your average councillor can complete anything between 2 and 15 hours of unpaid voluntary work whilst attending council meetings, visiting our town's residents or replying to the vast amount of emails we all receive from our residents and our Town Clerk.

An example of this occurred last month when ClIrs Matthew Walsh, Alan Turner and I visited the Greatmoor recycling centre just outside Westcott to see how this brand new state of the art plant turns household rubbish into energy and then sells this energy to the national grid.

We all met at the Princes Centre at 9am and returned at around 12.45pm, after grabbing a quick sandwich and a coffee we then all attended a Christmas events meeting that lasted until 2.30pm.

I then took part in our maintenance team appraisals finishing at 4.30pm, the remaining appraisals are pencilled in for the end of this month.

After going home for my dinner, a quick shower and change I was on the road to Aston Clinton to attend an event on behalf of our Town Council from 7pm to 9.00pm.

A total of 9 and a half hours of unpaid work performed in just a single day, obviously not all days are as manic as these thankfully or I would never be attending work for my employer.

This is just an example of what a Town Councillor can sometimes be expected to do for no financial reward, please bear this in mind that we are all very passionate volunteers that have been elected by you the town residents to represent you as best as we can.

### **Parking Review Update**

Since my Crosstalk article last June, I am pleased to inform you that Cllr Alan Turner and I met with Bucks County Council councillors on the 15th September 2016 to go through the final set of draft maps that outlined the proposed no waiting and permit restrictions for our town.

As I reported in my last update there was an online formal consultation carried out in August for residents of the affected roads, there were 154 responses in total.

As a result of these responses there have been a final few changes to reflect a more palatable option for our residents in the following roads.

After a lot of persuasion from our Town Council we have managed to remove the double yellow lines from the corner of Oak Road and Chestnut Road, as a compromise the grass verge side of this bend will now be protected by double yellow lines meaning our residents can park on this bend parallel with the houses along Oak and Chestnut Roads as at present

Residents that live in Jasmine Crescent were not entirely in favour of the proposed parking restrictions between the hours of 10am to 11am and 2pm to 3pm, around a dozen out of approximately 100 residents emailed during the online consultation expressing their views against these proposed restrictions. However, as this amount only reflected around 12% of the residents of Jasmine Crescent the proposals will remain as at present, this was mainly to protect the parking for local residents and not turn this road into a free all day carpark.

Willow Way residents were largely in favour of the restrictions between 10am and 11am and 2pm to 3pm, although residents with more vehicles than the amount of off road parking available were not in favour of this proposal. As a compromise it was agreed that a residents parking permit scheme between these same hours should be introduced. This way the only residents that will need to buy permits are the residents that have more vehicles than available off road parking. Every resident from Willow Way and Angood Close were sent a letter to fill in which of the 2 options they favoured, the result was a massive 90% in favour of the residents permit scheme.

Disappointingly the Town Council were unsuccessful in our attempts to get the Retreat, Berryfield Road and the Avenue included within this current parking review as the public consultation had already taken place. However funds permitting we will be having phase 2 of the BCC parking review starting around July 2017 to address these 3 roads above and any more roads that are suffering due to the implementation of this current parking review.

Copies of the final agreed maps and the online formal consultations comments are still available online, in the public Library and the Town Council office within the Princes Centre.

Once all the legalities have taken place and there are no issues, it is anticipated that this parking review will be implemented between January and March 2017.


### **News from St Mary's Church**

### LPD Lighting

The Town Council owns and maintains more than 500 street lamps known as 'footway lighting'; these are typically the 5 metre black painted lighting columns on the residential roads, the taller grey street lights on the main A4010 road are the responsibility of Bucks County Council who own and maintain them.

Operating costs for our street lights have gone up massively over the years; LED lighting (light emitting diode) technology has recently become mainstream, replacing traditional incandescent bulbs and has been proven to reduce dramatically electricity and maintenance charges by up to 80%. Most of you will have noticed that the main A4010 Wycombe Road/ Bell Street / New Road has been converted to LED by the county council.

The Town Council has for several months ran trial LED schemes at Longwick Road / Woolerton Court junction, at the end of Park Street and converted all the lanterns in Manor Park Avenue to LED's back in the summer. We chose this particular road because it has a high number of pedestrians until the early hours after the last train has dropped passengers off at the station. We have had no negative feedback to date, the light is of an equivalent quality and the taxpayer gets the benefit of lower utility bills, therefore we have made a decision to roll out new LED lanterns across the town over a period of a few years. The first tranche will appear within the next few months, and by 2020 most of the town should have been converted, then we can enjoy far lower electricity charges which of course are charged to council tax payers through our precept.

### Local Plan Update

The Local Plan continues to progress alongside the Town Plan which is looking increasingly likely will be assumed into the main Local Plan. The consultation process saw in excess of three thousand responses that I understand are currently being reviewed by the District Council.

Having taken the Chair of the Steering Group in early June, we have taken the opportunity to look at the work that has been already undertaken. We have had new people join us and we have provided briefing sessions for the newer members to be brought up to speed on Town Plan and how it has evolved.



Most importantly we held a long scrutiny session where Officers from Wycombe District Council were challenged on many areas of both the Town and Local plans. A huge amount of material was discussed and debated. Subsequently we have had meetings about the roads and the underpass at Wades Park. We have also received a presentation on the housing numbers at the reserve sites located in and around High Wycombe.

Wycombe will be publishing the final version of the plan in early 2017 prior to submitting to the Planning Inspector and further work continues to be undertaken. All minutes and presentations of the Steering Group are available at www.wycombe.gov.uk

I would also like to clarify that major infrastructure will be funded predominately by the developers. Plans are in place for two new primary schools, additional secondary and grammar school places and work continues on funding options for new roads and transport works.

In addition to the infrastructure funding, the Town Council will be receiving a share of money raised from the developers called the Community Infrastructure Levy (CIL). The Town Council has begun planning how we will allocate some of the money now and if you have ideas of how we can improve the town please contact the office, we would love to hear from you.

### **Planning Matters**

The main thing that all our local residents need to be made aware of and understand is that even though our Town Council Planning Committee meet every month to go through our towns planning applications, we can only give our comments and pass these on to Wycombe District Council (WDC) who then make the final decision to determine if planning permission is granted or refused.

So even if our Town Planning committee agree that any planning application would fit into the town's surroundings and offer WDC no objections to the building work going ahead, WDC can still disregard our opinion and refuse any planning applications as they have the final say, obviously this works vice versa as well.

There is a lot of talk regarding the local plan and the proposed 2500 homes development as mention in the above article by our Town Mayor, however I feel there are 2 pressing issues that you all need to be made aware of regarding planning applications within our town.

(**Planning Reference:15/07870/OUT**) - The ongoing saga of the Molins Sports & Social Club and their application to build 140 new dwellings, is scheduled to go to a planning appeal on the 31st January 2017. Please make sure you keep an eye out and visit the Town Council website where all planning decisions can be found.

(Planning Reference: 15/07825/OUTEA) - Park Mill Farm has currently got a proposal of up to 500 dwellings at appeal stage, this will be heard over an 8-day period between the 17th and 20th and the 24th and 27th of January 2017 in the council chambers at Wycombe council offices.

As with all Town Council meetings members of the public are most welcome to attend for the first 10 minutes of our planning meetings, please check the website for dates and times.
