Members were asked to declare any pecuniary or non-pecuniary declarations of interest and the nature of that interest which they may have in any of the items under consideration at this meeting. None were declared.

Noticeboard Maintenance 6.

Following the recent update of noticeboard content, Cllr Ball highlighted that the noticeboard situated on Upper Icknield Way is currently presenting materials on a single side rather than both. Given that the noticeboard can be viewed from both sides by pedestrians, it has been decided to utilise the second side for displaying additional information. S.Boyle

The matter of amending the event date will be discussed at the next committee meeting. **S.Marshall**

Cllr Marshall mentioned that some retailers voiced concerns surrounding shoplifting, and that retailers would welcome the opportunity to engage in a conversation with, or have the presence of a local Police Community Support Officer at a future meeting.
